## Superfund Public Meeting Scheduled for May 11

Options for soil cleanup for properties within Black Eagle are being developed

Superfund investigations of the Black Eagle residential areas and the Black Eagle Park have advanced to the point of considering cleanup options. Charlie Coleman, EPA's Remedial Project Manager, feels that enough is now known about levels of contamination, potential risks to human health, and the cleanup options under consideration that it is time to check in with the broader community, relay the progress, answer questions and seek community input. Also, the Agency for Toxic Substance Disease Registry (ATSDR), an independent scientific agency without enforcement authority, will present on their assessment of risks to public health due to remaining levels of trace metal contamination of soil from historic smelting operations. Since only a portion of the yards in Black Eagle are expected to have high enough levels of trace metals in yard soil to qualify for cleanup, the ATSDR will also provide practical advice on how to minimize exposure and remain safe when working or playing in yards. The former smelter site and possible smelter impacts to the Missouri River are also part of the Superfund investigation. EPA continues with its plans to review copious existing information about contamination levels within the smelter site in order to scope further site investigation needs. Initial efforts have also begun by the Black Eagle Technical Assistance Group (TAG) and the county to seek out an entity that might assume management responsibilities for the smelter site, currently owned by BP, for the benefit of future possible public access. According to Ellen Sievert, Great Falls-Cascade County Historic Preservation Officer, the former smelter site is rich in early settlement and Native American history and it presents wonderful opportunities for trail connectivity and other possible uses. Ellen has recently formed the Upper Missouri River Heritage Area Planning Corporation, a private, non-profit group that is seeking to establish a Heritage Area along water front within and downstream of Great Falls, and she sees the smelter site as an important part of the Heritage Area.

Historic smelter practices also included disposing of large volumes of slag, a waste product from smelting, into the river. EPA has teamed with the Montana Department of Fish, Wildlife and Parks (FWP) to conduct sampling of various aquatic species to assess any impacts associated with the slag. Jason Mullen of FWP presented to the TAG committee at the March meeting on their trials and tribulations in sampling a wide range of fish and aquatic invertebrates both upstream and downstream of the slag. Once laboratory testing is complete, EPA will update and extend on a prior screening-level ecological risk assessment to help inform a decision on the need for further investigation.

**EPA will host the Superfund meeting on May 11 in the Black Eagle Community Center from 7:00 to 8:30 PM.** The public is encouraged to attend!

This article is provided by the Black Eagle Technical Assistance Group (TAG), a non-profit group of local residents and government staff that meets monthly to track Superfund project developments in detail and provide feedback to the agencies. ## County Dog Ordinance

### Dogs at Large

"At large" means off the premises of the owner and not under control.

No dog covered by this ordinance shall be allowed to run at large in the county, which includes Black Eagle. Violation of this shall be a misdemeanor.

Any dog found to be running at large in the county may be seized and impounded by most law enforcement officers.

## MApril cleanup scheduled for May 21 and June 4, 2016

The community-wide cleanup effort for residents, called MApril, is scheduled for **May 21 and June 4** from 8 a.m. to noon throughout Great Falls. **NOTE: There has been a date change to accommodate the Base schedule.** A Base military pick-up crew and truck will be assigned to help in Black Eagle again this year.

One of the primary sponsors, NeighborWorks, is seeking cleanup teams to work on local parks, roads, trails, and other public areas in Black Eagle. The civilian volunteers will join crews from Malmstrom Air Force Base in bagging and disposing of the winter accumulation of trash. As in years' past, the Base will provide a truck just for Black Eagle debris and haul it to the landfill.

**To volunteer for a cleanup team in Black Eagle, call Terry Miller at 453-4908. Miller is recruiting team captains and team members to work on public areas of Black Eagle. Families are also urged to clean up their properties and send trash to the dump.**

Roger Bridgeford, general manager of Montana Waste Systems and the High Plains Landfill, is donating dumping fees again this year; the fees can run into the thousands of dollars, a huge donation to the local cleanup effort. In addition to NeighborWorks, Montana Waste Systems and MAFB, other sponsors are the City of Great Falls, the Chamber of Commerce and the Montana Department of Transportation.

- Large trees or branches more than four feet long;
- Debris from construction sites (such as a demolished house);
- Asbestos materials;
- Petroleum or PCB contaminated soil;
- Mercury thermometers;
- Sharps/ needles;
- Chemotherapy drugs;
- Unwanted or expired prescription drugs;
- Large appliances.

**Upper Missouri River National Heritage Area**  
By Upper Missouri River Heritage Area Planning Corporation

In order to bring together the many assets in our area, a group of citizens have been working since January 2015 to explore the formation of a National Heritage Area in the Upper Missouri River area. The group is forming a not-for-profit organization and a Board of Directors was installed May 11, 2015; the first official meeting was held May 28, 2015.

The Board of Directors has defined a tentative boundary for what is being called the "Upper Missouri River National Heritage Area" as follows-all of Cascade and Chouteau Counties; additionally lands east from Chouteau County bordering the Missouri River to capture the entire Upper Missouri National Wild and Scenic River, which terminated on the east at the Kipp Bridge on US 191, and further all of the lands bordering the Upper Missouri River Breaks National Monument, as well as lands along the river to the Gates of the Mountains. The not-for-profit Upper Missouri River Heritage Area Planning Corporation, Inc. (UMRHA) was created to initiate a collaborative effort to establish a National Heritage Area (NHA) based on the region's nationally significant natural, cultural, historic, and scenic resources. Receiving this federal designation would be **honorary and would not affect any public or private property rights**. It will allow access to federal funding for coordinated marketing/management by all of the entities within the defined area.

The Upper Missouri River Heritage Area Planning Corporation, Inc. is a registered Montana not-for-profit entity and the Board will soon be filing for 501(c)(3) status with the IRS.

## Black Eagle Park 4<sup>th</sup> of July Celebration

The Art Higgins Memorial Park is located on Railroad Ave behind Borries Restaurant at 1800 Smelter Ave. The park groundbreaking ceremony was held in 1974. Montana Power donated the land for the park to Cascade County. The land donation was to develop a park dedicated to the memory of Art Higgins, a lineman for the company who was killed in a power line accident. Art and the Higgins family were active members of the Black Eagle community for many years. The park is owned by Cascade County. A group of dedicated volunteers has done all the development, maintenance, and upgrades to the park. The volunteers are too numerous to name over the last 45 years from when the first group of residents saw the need for a park in Black Eagle. There are families who have dedicated their lives to the development, maintenance, and future of the park, the children of Black Eagle and surrounding area. The only funding for the park over the years has come from donations and the annual 4<sup>th</sup> of July Picnic, which has been held almost yearly since 1974.

Without volunteers and coordinators the park will not have the opportunity to celebrate 42 years of a Black Eagle and Great Falls 4<sup>th</sup> of July tradition. The menu has always consisted of the polish sausage with sauerkraut, hamburgers, hot dogs, watermelon, fresh corn on the cob, along with a variety of entertainment and games for all ages. A raffle, silent auction and 50/50 tickets have also been offered with exciting prizes. Attendees have been able to cool off with their favorite beverage whether it is water, pop, or beer, and top it off with a cool ice cream treat.

For 41 years people from all over the country have come to celebrate the nicest park in the county, see old friends and make new friends. The Park Board needs community members to step up to continue the celebration into the 42<sup>nd</sup> year.

### Black Eagle-Cascade County Water and Sewer District

A public hearing, which was advertised in the Great Falls Tribune legal ads, was held during the Civic Club meeting on March 2, 2016. The purpose of the public hearing was to address a RRGL grant application through the Department of Natural Resources and Conservation for the sewer main reconstruction project. The grant application will be part of the Infrastructure Bill presented to the 2017 State Legislature. The public hearing was to gauge public support for this grant application. There was unanimous support for this grant application.

The public hearing was addressed the proposed rate increase for water and sewer service. The City of Great Falls has proposed a 10% rate increase for water and a 3% rate increase for sewer. The Board of Directors has no choice but to pass this rate increase on to the water and sewer customers in Black Eagle. The only public comment was one of understanding that the District has to pass the rate increase on. The increase will appear on the May water bill and on the November tax bills for the sewer.

A national do-not-call registry has been established to address unwelcome telemarketers, with the exception of businesses with whom you have an existing relationship and certain non-profit and political organizations. Commercial telemarketers are not allowed to call you if your number is listed on the registry. Consumers may register the residential and wireless numbers at no cost, either by telephone or by internet. YOU MUST call from the phone number you wish to register. The number will be effective 31 days following your registration. Your number will be on the registry permanently. You can also remove it at any time.
